#### Hearings

• 6:10 p.m. – Enforcement Order Edward Stuart – Continued

The Commission has received a delineation from Ward Smith, which seems complete. We will approve the restitution plan Ward sent out. Part of it involves moving the structure because it's within the 100' buffer zone. Where the trees were cut down needs to be re-planted. On a motion from Grace to accept the plan from Ward Smith, Brittany seconded, all said aye and the vote was unanimous in favor. The main concern of the ConCom was the deforestation of land within the 100' buffer.

On a motion from Grace to switch the pickleball hearing with Thompson Road, Brittany seconded, all said aye and the vote was unanimous in favor.

• 6:20 p.m. – RDA – 259 Thompson Road – New Construction

Site visit. Jack is building new construction on the footprint of a former dwelling. He has gotten a delineation from Ward Smith and so far is avoiding all the wetlands, so there is no issue at this time. On a motion from Grace to make a determination to approve the RDA with a negative 2 – The work described in the request is within an area subject to protection under the Act, but will not remove, fill, dredge or alter that area. Therefore, said work does not require the filling of a Notice of Intent – Brittany seconded, all said aye and the vote was unanimous in favor. The RDA was then signed by the Commission.

## • 6:30 p.m. – RDA – Parks & Rec - Pickleball Court

Jan called the meeting of Parks & Rec to order at 6:16 p.m. They are proposing 4 pickleball courts on the South River Meadow along with a redesigned driveway for the Highway Department. As the driveway currently exists, visibility to Shelburne Falls Road is insufficient, and more steep at the entrance than is good. They are asking for a pickleball court on this site because they are currently using the basketball court on the ballfield and are sometimes displacing others. They picked the South River Meadow because it would be far enough away from the river. Once funding is approved, a wetlands delineation will be made. Ward Smith will get back to Jan on this. Emily Stockman, Senior Scientist, Stockman Associates, has also worked with the property and her fee would be \$1,400/day. She will look at the isolated wetlands located on the site and note if any plans would have a negative impact on the wetland or natural habitat. At the next meeting of Parks & Rec on October 3, monetary issues will be discussed. For the Conservation Commission, it was stated that today is not to determine anything other than if the project fits within the specifics of the wetlands protection act. On a motion from Grace to continue the hearing discussion to October 10, or at a later date, Brittany seconded, all said aye and the vote was unanimous in favor.
