Grace asked how Edward was doing with moving the structure. Edward asked if he could put it off until spring. He said he understands that it must be moved. Asked what the delay reason was, Edward said he has been swamped with work. Agricultural exemption? It's not currently agricultural, so he would have to go through the regular permitting process. Postpone continuation until the end of April? Can issue an amended enforcement order specifying terms. Mr. Stuart was advised to contact Ward Smith to help file an NOI to build a structure or house, since he is allowed to build on the property, but will need an order of conditions from the ConCom. On a motion from Grace to extend the enforcement order to April 30 and amend it to make it clear that the structure must be removed from the river, Tony seconded, all said aye and the vote was unanimous in favor. As far as putting in gravel, grading, etc. it would depend if it's in a resource area/wetland.
