The meeting was opened, and then closed as Ward Smith couldn't attend. On a motion by Grace to open the meeting and then close it, Tony seconded, all said aye and the vote was unanimous in favor...

Other Business

• Discussion – Nexamp and Abutters – erosion issues

Try to find solutions where we have jurisdiction and where it is not within ConCom's purview, try to direct the abutters to the proper party. Identify where water was flowing over the silt fence? How is the silt fence holding up? It's not designed to be permanent, and vegetation starts to take over so it's not needed. Gerry LeBlanc asked if the ConCom would want to come and walk his property, which abuts the Nexamp facility. He told the commission that there are habitat issues, as the leaf-cover is being washed away. Devlin says she has water issues in her basement. The Newman/Nexamp site is shedding water onto her property. She feels that this is the result of 30 acres having been clear-cut. Some of this was mandated by the fire department for emergency access. Water goes over the culverts, which can't handle the volume. Gerry admitted that the video he had sent was taken last year during the heavy rain. He also admitted that he had no flooding in his house nor in Devlin's house, nor was his sump pump overwhelmed by the rain, nor had he any overflow from Nexamp since. He also indicated that there had been no overflow of sediment, debris into the Keyes swamp across the street. Upon given a diagram of the site and his abutting property, he indicated with a red pen approximately where the overflow came from the Nexamp site and the direction of the water overflow.

Grace remarked that of the area we have been covering, silt has been removed, but that was damaging vegetation. Grace has also been following up over the past year with many site visits between July and August of last year. We need to check with Nexamp to see if they are doing maintenance after the severe storm events that have occurred. Plantings that were promised seem not to have been made.
