permission from the owners up to 381. It was suggested that Ed's attorney draw something up and have it signed. Ed said the building inspector told him he would need a variance, which he would get for the width of the property. Also a variance for the width of the right of way. Can't make a decision without o.k. from all the property owners, and it should be done by certified mail. Ed said it might take some time to get the permissions and asked if he might be continued for four weeks. On a motion from Grace to continue this hearing to the September 8 agenda, Brittany seconded, all said aye and the vote was unanimous in favor.

Lincoln had done a revision on the NOI that had been sent out. Waiting to hear from Misty-Anne of Mass Wildlife. Anything that involves the river involves Natural Heritage. Lincoln said that they don't want to spray when bees are roaming among the flowers. We will wait until next meeting and we should have an answer from Natural Heritage by then. On a motion from Grace to continue this hearing until the next meeting on August 27, Tony seconded, all said aye and the vote was unanimous in favor. Janet was in agreement. Approval takes about 10 days.
