# **Town Meeting Government**

Conway's form of governance is the open town meeting/Board of Selectmen. An open town meeting is a form of town meeting in which all registered voters of a town may vote (as opposed to having elected town councilors vote on behalf of the town's population). This form of government is typical of smaller municipalities in New England. As a form of government, it eliminates town councilmen as middlemen.

In the words of Henry David Thoreau,

I am more and more convinced that, with reference to any public question, it is more important to know what the country thinks of it than what the city thinks. The city does not think much. On any moral question, I would rather have the opinion of Boxboro than of Boston and New York put together. When the former speaks, I feel as if somebody had spoken, as if humanity was yet, and a reasonable being had asserted its rights — as if some unprejudiced men among the country's hills had at length turned their attention to the subject, and by a few sensible words redeemed the reputation of the race. When, in some obscure country town, the farmers come together to a special town-meeting, to express their opinion on some subject which is vexing the land, that, I think, is the true Congress, and the most respectable one that is ever assembled in the United States.

In Massachusetts any town with fewer than 6,000 residents may adopt only an open town meeting form of government. (Massachusetts towns with 6,000 or more residents may optionally adopt a representative town meeting form of government.) The Board of Selectmen calls the town meeting by issuing the warrant, which is the list of items—known as articles—to be voted on, with descriptions of each article. The Moderator officiates the meeting by reading each article, explaining it, and making sure the rules of parliamentary procedure are followed, interpreting voice votes and counting other votes. The Finance Committee makes recommendations on articles dealing with money, and may draft the proposed budget. The Town Clerk serves as the clerk of the meeting by recording its results. Town Counsel makes legal recommendations on all articles of the warrant, to ensure town meeting is acting lawfully. All registered voters are free to attend and vote on all articles.

In the Town's Annual Report, which is available at the Town office at 32 Main Street, you will find the names of the various Boards and Committees that take responsibility for the smooth functioning of this community.

It is important to know that Conway's annual budget and other significant issues are decided at the Annual Town Meeting which takes place the second Monday in May at 7:30 p.m. at the Conway Grammar School. During the year, town business is handled by the Select Board, which meets each Monday at 6:00 p.m. at the Town Office from January to Town Meeting in May, and then every other Monday through the end of December.

Conway is one of the few towns in Massachusetts that still conducts a non-partisan form of town government. Candidates for elected office are nominated at the Citizen's Caucus, which meets in

early March at the Town Hall, 5 Academy Hill Road. Conway residents are encouraged to participate in this important process. The annual Town Election takes place at the Town Hall on the Thursday following the Town Meeting.

#### Annual town meetings

Annual town meetings are held the second Monday in May and may also be known as the annual budget meeting. State law requires that they be held between February 1 and June 30 (the end of the fiscal year). At this meeting, the town takes care of any outstanding housekeeping items it has remaining before the end of the current fiscal year, and prepares to enter the new fiscal year by approving the new fiscal year's budget. It may also vote on non-budgetary issues on the warrant, including the town's general and zoning bylaws and citizens' petitions.

An article may be placed on the warrant by the Selectmen, sometimes at the request of town departments, or by a petition signed by at least ten registered voters of the town.

#### Special town meetings

Special town meetings are held whenever necessary, usually to deal with financial or other pertinent issues that develop between Annual Town Meetings. They function the same as an annual town meeting, only the number of signatures required on a petition rises to 100. While the Selectmen generally call such a meeting, voters may call one through petition, and the number of signatures required on a petition to call a Special Town Meeting is 200 or 20% of the registered voters, whichever number is lower. The selectmen have 45 days from the date of receiving such a petition to hold a Special Town Meeting.

#### Town Election

The Town Election is held the Thursday after the Annual Town Meeting in May.

# REAL ESTATE AND PERSONAL PROPERTY TAXES (FY2017)

### What is the current tax rate?

The tax rate for FY2017 is \$17.75 per \$1,000 of taxable value. If your taxable value is \$300,000, you can calculate the tax by the following formula: \$300,000/\$1,000 = 300.

300 \* \$17.75 = \$5,325.00tax for the year

# What is the "Comm Pres Fund" listed on my bill?

The Community Preservation Fund is a 1.5% surcharge on the tax which goes to a fund to be used specifically toward recreation, historic preservation, open space and low-income housing projects. The state contributes toward the fund, too, in the towns that have adopted it. It is applied to everyone's bill at 1.5% of the amount of the tax and is administered by a separate CPF Committee here in town. This money does not go into the general operating funds of the town, only to the specific CPF projects, as approved by Town Meeting.

# At what ratio is property assessed?

By law, property is valued at 100% of full and fair cash value, based on proven sales in the Conway market.

# What does 100% of full and fair cash value mean?

The courts have defined this phrase to mean "current market value". Thus, in determining value, the Assessors seek to approximate what property would sell for on the open market. The mass appraisal process of assessing allows a an acceptable range of value as compared to the appraisal of individual properties for mortgages or estates.

# Can I check the valuation of any property or just my own?

Valuations are public record. You can either call or come in to the Assessor's office with the property location or owner's name to find the current or past valuation for any property in Conway.

# How do I find the ownership of property or when it was sold or the price paid?

The Assessors' office has this information (updated monthly) and a book and page reference on the property record card all properties. You can also research this at the Franklin County Registry of Deeds, now located on Olive Street in Greenfield or available online at http://www.masslandrecords.com/.

# What is the assessment date of all property?

The assessment date is the January 1st preceding the fiscal year, so the FY2017 bill reflects the property's condition on Jan. 1, 2016.

# Whose name goes on the tax bill? If a property is sold, when will the bill reflect the new ownership?

The name on the tax bill is the record owner(s) as of January 1st preceding the fiscal year, however the new owner's name is included on the bill if the property has been sold, in order to have it reach the person responsible for paying the bill. Property tax bills are mailed to the owner of record, not to a mortgage company, so it is the property owner's responsibility to see that it is forwarded if someone else will actually be paying it.

#### How do I change my mailing address for tax billing?

Contact our office by mail or e-mail to change a mailing address – otherwise we must use the mailing address given on the deed – we don't always know if you have moved to your new Conway property or where you receive your mail.

#### How do I change a name on my property/tax bill?

The only ways to change a name on a property/tax bill is to either record a new deed or to provide the Assessors' office with a probated will.

#### How often are tax bills issued?

The Tax Collector mails bill semi-annually, usually at the end of March and end of September.

#### When are tax bills due?

Tax bills are due on May 1 and on November 1.

#### What is an abatement or an exemption?

An abatement is a reduction in the taxable value of a property if it is overvalued — it has nothing to do with one's ability to pay the tax but only with the value of the real estate or taxable personal property. An exemption is a reduction in the amount of tax to be paid based on a personal circumstance of the property owner.

#### **ABATEMENTS**

#### Who is eligible to file for an abatement?

Anyone who feels that their property is overvalued in itself or exempt from taxes may file for an abatement. You should ask yourself these questions before filing:

Is the assessors' information on my property record card correct?

Is my value proportionate with other similar Conway properties?

Is my value in line with recent sale prices in Conway?

Would I sell my property for the assessed value?

Remember that you are appealing your assessment (taxable value), not the amount of taxes due. Filing for abatement does not delay the date you must pay the billed tax and paying it late may result in interest charges or other fees from the Collector.

#### Where do I get applications for abatement?

Applications are available at the Tax Collector's office, the Assessors' office and on the town website at

http://www.townofconway.com/departments/assessors/ - see "Forms and Downloads".

#### When do I file for an abatement for overvaluation? Is there a fee?

You must file after the final bill has been mailed and by its due date. This is usually Oct .1 - Nov. 1 of each year. By law, the assessors cannot accept applications for abatement at any other time or a late filing. There is no fee at the town level for filing for abatement, only if the matter is carried on to the state Appellate Tax Board (see below).

Where do I file an application for abatement?

You can (1) mail in an application (USPS postmark on or before the final filing date), (2) bring to the Assessors' Office in the Town Hall, (3) leave it in the Assessors' mailbox at the Town Offices or (4) submit it by e-mail to assessors@townofconway.com.

After I've filed an application for abatement, what is the process?

The Assessors will review your application at a regular meeting and would be glad to have you present it in person. In any case, they will make an appointment to visit the property for a complete inspection, inside and out. This gives you an opportunity to show them exactly what you think is an error in their description of the property or any feature that you think alters the value. A site visit usually takes about 30 minutes. They will then reconsider your application at their next meeting, which you are also welcome to attend if you wish, and, if appropriate, will recalculate the taxable value of your property. They then vote on whether to grant abatement and the amount to be given and complete paperwork to officially notify the Tax Collector of the change. Your taxable value for the following year will start at the abated value.

Are abatement applications public records?

Abatement amounts and application reports are public records. However, individual abatement applications are not available to the public for inspection under the public records law.

What happens if my abatement is approved?

If your application for abatement is successful, you will receive a notice indicating the amount of the abatement in tax dollars and the Tax Collector will apply the abatement to reduce your spring tax bill. You can ask the Assessors for the details on how much your taxable value was reduced and why.

If the Town denies my application, do I have any recourse?

If you disagree with the Assessors' decision on your application or on the amount the value was adjusted, you have 90 days in which to ask them to readdress the application and you may add pertinent information to your original request.

If you are still dissatisfied with their answer, you can file an appeal within 3 months of the date of denial to the:

The application is not difficult to complete, and the ATB's purpose is to be an impartial professional arbitrator. Caution: If you do not pay the tax bill on time, in full, as billed, you lose your right to appeal.

#### **EXEMPTIONS**

### Who is eligible to file for a personal exemption?

Exemptions are based on the personal circumstances of the property owner and are available to

- (1) qualifying veterans and their widows,
- (2) the blind,
- (3) senior citizens with limited financial means
- (4) surviving spouses and children with limited financial means.

Each category has its own qualifying factors and you must reapply each year to continue to receive an exemption. The person filing for the exemption must have at least a partial ownership in the real estate (which may be a life tenancy), it must be their legal residence (even if they are in a hospital or nursing home), and they must provide certain personal information as part of the application.

Filing for exemption does not delay the date you must pay the billed tax and paying it late may result in interest charges or other fees from the Collector.

# Where do I get applications for exemption?

Applications are available at the Assessors' office and on the town website at http://www.townofconway.com/departments/assessors/ - see "Forms and Downloads".

### When do I file for an exemption? Is there a fee?

You must file with 90 days after the final bill has been mailed. This is usually Oct .1 - Dec. 31 of each year. By law, the assessors cannot accept exemption applications at any other time or a late filing. There is no fee for filing for exemption.

### Where do I file my application for exemption?

You can (1) mail in an application (USPS postmark on or before the final filing date), (2) bring to the Assessors' Office in the Town Hall, (3) leave it in the Assessors' mailbox at the Town Offices or (4) submit it by e-mail to assessors@townofconway.com.

#### After I've filed an application for exemption, what is the process?

The Assessors will review your completed application at a regular meeting, but any personal or financial information that you must provide is NOT revealed in public meeting and is not available to the public. They then determine if you qualify for the exemption requested and the amount to be given and complete paperwork to officially notify the Tax Collector of the change for this tax year.

### Are exemption applications public records?

Completed applications are not public record, and are kept in a locked file. Individual abatement applications are not available to the public for inspection under the public records law.

#### What happens if my exemption application is approved?

If you qualify for an exemption, you will receive a notice indicating the amount of the reduction in both your tax bill and the corresponding Community Preservation Fund surcharge and the Tax Collector will apply the reductions to reduce your spring tax bill.

If the Town denies my application, do I have any recourse?

If you disagree with the Assessors' decision on your application or on the amount adjusted, you have 90 days in which to ask them to readdress the application and you may add pertinent information to your original request.

#### WHAT CAN BE RECYCLED?

Conway has been very successful in its recycling efforts. The Town manages to save a great deal of money each year by doing so. There is a shed for exchange of clothing, shoes and a small number of books. There is also a large metal container for the collection of books which will be recycled off-site (no browsing, please). The Attendants will gladly provide information and assistance.

# Permit required to use the Conway Transfer Station

Board of Health Regulations state that the use of the transfer station is limited to Conway residents who have purchased and display a special permit sticker on their vehicle. Such permits may be obtained from the transfer station attendant for an annual fee of \$10 upon demonstration of proof of residency.

# Conway Transfer Station—Schedule of Fees


