South River Meadow proposed pickleball courts: Jan met with CPC and Open Space three times. Open Space was worried about Open Space, runoff, etc. They wanted conservation commission buy-in. Was too late for the articles deadline for the warrant.

Ongoing Maintenance and Repairs – court issues – tennis court has low spots with puddles. Can this be fixed somehow with composite material Jan saw advertised – could we compare costs? The "no climbing" sign needs to be replaced on the retaining wall. Lets keep the gate closed for access road from upper lot. Signage for pickleball playing times and contact info. Shed – Julie checked into it – looks like it just needs paint and new bulletin board? Nobody has the key to the double doors. Spring work bee – could we piggy-back onto the baseball work day? Could be in April over April break Sat or Sun? We will resupply tennis balls and rackets and basketballs – Jim motioned, Julie seconded, voted unanimously \$250 for Jan to spend on these items. Jim will repair the picnic tables – Jan motioned, Julie seconded, voted unanimously for Jim to spend \$250 on lumber
