Conway Planning Board Minutes Thursday, October 5, 2017

Public Hearing on Proposed Temporary Moratorium on Commercial Recreational Marijuana Establishments.

1) Public hearing opened 7:05 pm by Chair

Chair McClintock introduced the proposed moratorium citing that this falls under a zoning bylaw and so necessitates at public hearing. She stressed that the moratorium was only in regards to commercial establishments. A moratorium is recommended because the timeline for state regulations concerning commercial marijuana laws may not allow the town enough time to consider any potential additions to its own bylaws before licensing opens on July1, 2018. There was discussion of potential revenue to the town, which would include 3% of local sales tax collected and up to 3% of gross revenue of the commercial business. Roy Cohen raised concerns that the moratorium might appear to make Conway hostile to the marijuana business and suggest the article be worded in a more welcoming way. There was also concern about applying the bylaws equitably Vis a-á vis other businesses. Because the town of Conway has very lax bylaws regarding businesses nothing the town currently has in the bylaws would address commercial marijuana establishments regarding location, parking, signage, hours of operation etc. There was discussion that voting down the moratorium may accelerate any potential applications and if approved these establishments would be grandfathered against any future perhaps more restrictive bylaws. A question arose if we should hold a pre town meeting for the Oct. 30 special town meeting. It was determined that there was not enough time. It was brought up that if a moratorium was voted in and Conway them found the state regulations to be adequate, the moratorium could by lifted at annual town meeting. Maintaining local control is the point of the moratorium. For example marijuana edibles are not considered consumables so the Board of Health has no authority to inspect kitchens where marijuana edibles are prepared. The moratorium would allow time for Conway to address such issues if warranted. 8:25 Motion to close public hearing- Joe S. Second- Mary M. All in favor.
