The purpose of the meeting was to gather input from the public on potential solar bylaw changes in Conway, specifically focused on several priority areas of interest to the Planning Board. There will also be a public hearing on March 24 to formally consider bylaw changes. The topics of discussion tonight were:

- Require special permit process/ site plan review for all proposed new large solar facilities, over 5 acres;
- Increase setback distances from array perimeter to abutters;
- Strengthen requirements for sound testing and for source of noise to be further from perimeters:
- Require construction site monitoring (paid by applicant) for all proposed projects over 5 acres;
- Require line of sight visibility testing prior to permitting:
- Increase screening/planting and maintenance of plant screen over life of array; and
- Other topics not raised above.

The Planning Board expressed how helpful this event has been, and thanked everyone who participated. Comments are welcome and encouraged to planningboard@townofconway.com – including specific detail is helpful. Comments before March 2nd or 3rd are appreciated to keep the process moving.
