1. Approval of minutes of January 5, 2023

On a motion from George to approve the minutes of January 5, 2023, Bill seconded, all said aye and the vote was unanimous in favor, with the exception of Susan who abstained.

Wireless/telecommunications bylaw, next steps (George/Beth)

Proposed changes discussed in the last meeting have been added to the initial revision proposal. Further suggestions: Small cell installations are designed to accommodate 5G and are 100-150 ft. apart, mostly in larger towns. Rights of way are a consideration. who has the authority to regulate? The Selectboard has the authority for siting or moving poles. What rights do we have over Rte. 116? - as it's a state road. Our final draft needs to go to a public hearing and needs to be as complete as possible. Some mention covering the possibility of small cell installations should be included in the bylaw revision.

3. Vertex Tower Assets and Roaring Glen Farms, LLC: special permits, communications, updates

Beth has written to both of them about their special permits but has heard nothing back. She has also sent the email to Francis Parisi, as their permits may be in jeopardy.

4. Variances for common driveway by-laws

Current bylaw is pretty robust compared to other towns. Parallels with requirements for subdivision driveways and provides for emergency access. Under what circumstances would we issue a variance? If a shared driveway is turning to a common driveway (three or more properties), approval of the legal agreement would need to come from the Planning Board. If the slope were more than what is allowed, we would likely issue a variance upon approval of the ZBA.

5. NexAmp Solar Array update

They are waiting for a delivery date for the new inverters.
