IT

The Executive Office of Technical Secuirty & Services (EOTSS) has given us free services to develop a Cyber Incident Response Plan (CIRP) in the event of a cyber security attack on the town's system. Our team consists of Jan Warner, Don Bates, Adam Reed, Roy Cohen, Erica Goleman and myself, along with members of NuHarbor and EOTSS. We are meeting twice weekly for an hour to review what procedures the town already has in place and then begin to develop the plan, and it should take 3-4 weeks to complete. Eventually we will hold a tabletop exercise to tweak the plan. Just so you are aware, a big problem for small towns like ours is not all volunteers use town email accounts – they are costly to provide – but this involves security risks, as does the use of personal phones to house emails.

I also participated in the CISO (Chief Information Security Officer) meeting held by EOTSS. I am participating in this to provide feedback and also make sure Conway is as up to date as possible regarding new threats and opportunities.
